1	This application is only valid for the 2020 Hopefield Fynbos Show.
2	Please provide us with a logo to advertise your product that will be for sale (optional) and attach a photo of your stall's appearance.
3	Applicants must declare ALL products and services offered during the Show on this form. Products and services are LIMITED to what had been declared.
4	<b>Under no circumstances is fireworks or any form or crackers allowed to be sold.</b>
5	Location preference of a stall can be stated on this form, but is not guaranteed. No overnight camping is allowed on the show grounds. <b>HONOUR DEDICATED PARKING ARRANGEMENTS.</b>
6	Local applicants will receive preference in case the number of stalls are limited.
7	Organiser's decision with regards to allocation and location of stalls is NOT NEGOTIABLE.
8	Stalls must be setup and be in attendance according to the trading times set out above. If stallholders disobey trading times, they may be asked to leave and will forfeit their fees. Stallholders must be set-up and trading from the Thursday. If not, you will not be allowed to the Fynbos Show in 2021.
9	Stallholders must comply with all relevant licensing and permit requirements.
10	Upon signing this application, the organisers (Fynbos Committee, Hopefield Sport Club and/or Landowner) are hereby indemnified against any losses or injury incurred (immediate or future) by the stallholder or his/her assistant.
11	Stallholders utilizing flammable materials or fuel (eg. LPG or fire) must provide fire fighting equipment and adhere to prescriptions of the fire brigade. Inspections will be conducted.
12	The organisers do not offer any guarantee as to the number of attendees at the show.
13	The stallholder's fee must be paid via EFT into the nominated account, which will be on the acceptance letter that will be send to you, on or before 30 June 2020. Signed application form to be handed in.

16	All applications subject to approval. Submission of application form does not imply approval. You will be notified via email of your acceptance.
17	The organisers do not supply any infrastructure or facilities to stallholders.
18	The stallholder warrants that no stolen, counterfeit or illegal goods or services will be sold or offered for consumption by them or any other person operating their stall during the course of the Show.
19	The stallholder hereby indemnifies the organiser and holds them harmless from damages in relation to any trademark, copyright or intellectual property transgressions of the applicant or any other person operating their stall during the show.
