## TERMS

- 1 This application is only valid for the 2025 Hopefield Fynbos Show.  
APPLICATIONS CLOSE ON THE 15th OF JUNE 2025.
- 2 Please provide us with a logo to advertise your product that will be for sale (optional) and attach a photo of your stall's appearance.
- 3 Applicants must declare **ALL** products and services offered during the Show on this form. Products and services are LIMITED to what had been declared. **No** food preparation stalls will be allowed in the tent. **No** cars or trailers will be allowed in the tent.
- 4 **Under no circumstances are fireworks or any form or crackers allowed to be sold.**
- 5 No overnight camping is allowed on the show grounds. **HONOUR DEDICATED PARKING ARRANGEMENTS.**
- 6 Local applicants will receive preference in case the number of stalls is limited.
- 7 **The decision of the organisers with regards to the allocation and location of stalls is NOT NEGOTIABLE.**
- 8 Stalls must be setup and be in attendance according to the trading times set out above. If stallholders disobey trading times, they may be asked to leave and will forfeit their fees.  
Stallholders must be set-up and trading from the Thursday. If not, you will not be allowed to the Fynbos Show in 2026.  
**No exceptions will be made.**
- 9 Stallholders must comply with all relevant licensing and permit requirements. Food stallholders, please take note that you must have a COD from the West Coast District Municipality, even if you have a COD from another municipality.
- 10 Upon signing this application, the organisers (Fynbos Committee, Hopefield Sport Club and/or Landowner) are hereby indemnified against any losses or injury incurred (immediate or future) by the stallholder or his/her assistant.
- 11 Stallholders utilizing flammable materials or fuel (e.g. LPG or fire) must provide firefighting equipment and adhere to prescriptions of the fire brigade. Inspections will be conducted.
- 12 The organisers do not offer any guarantee as to the number of attendees at the show.
- 13 The stallholder's fee must be paid via EFT into the nominated account, which will be on the acceptance letter that will be sent to you, on or before **30 June 2025**. If full payment has not been received on or before **30 July 2026**, you will be removed from the list and agree that we may keep any amount already paid.
- 14 **Reference** code that must accompany your EFT is your **CELL PHONE NUMBER**.
- 15 Proof of payment of stallholder's fee, together with this signed application form and the photo of your stall, must be forwarded to email [uitstaller@hopefieldsportsclub.co.za](mailto:uitstaller@hopefieldsportsclub.co.za) or faxed to 063-406-0421
- 16 All applications subject to approval. Submission of application form does not imply approval. You will be notified of your acceptance.
- 17 The organisers **do not** supply any infrastructure or facilities to stallholders – **therefore you are responsible for you own extension cords when using electricity and your own gazebo's/tents when indicated an outside stand**. No stall selling food that must be prepared will be allowed inside the tent.
- 18 The stallholder warrants that no stolen, counterfeit or illegal goods or services will be sold or offered for consumption by them or any other person operating their stall during the Show.
- 19 The stallholder hereby indemnifies the organiser and holds them harmless from damages in relation to any trademark, copyright or intellectual property transgressions of the applicant or any other person operating their stall during the show.
- 20 The stallholder hereby agrees that the organisers cannot be held responsible for any force majeure, or the consequences thereof which may impact on the event, or stallholders or attendees at the event.
- 21 **Stallholders to please ensure that contact details provided are readable and correct.**

By signing below, I acknowledge that I have read, understood and accept the terms above as binding on myself and further warrant that the information provided by me in the application form is correct.
